Incorporation of Tricolor:

The incorporation of the tricolor into the logo is a powerful symbol of the Institute's connection to India. The logo consists of the letters 'CA' in blue colour with a tri colour tick mark (upside down) with white background. The blue colour not only stands out on any background but also denotes creativity, innovativeness, knowledge, integrity, trust, truth, stability, and depth. The upside-down tick mark, typically used by Chartered Accountants, has been included to symbolise the wisdom and value of the professional.


'India' is also added in the logo, as it epitomizes the Institute's connection to India First approach and commitment to the serve the Indian economy in public interest.





The primary color of the new logo is blue, which has been culled from the ICAI logo. Blue is a color that is associated with divinity, immortality, bravery, and determination.  While members are encouraged to use the new CA India Logo as published on letterheads, visiting cards, website etc, a transition time of one year has been provided to use existing stationary/signage replacement etc.

EXCEL TIPS

IMAGE is a new function, which is currently available only to Microsoft 365 users for Windows, Mac and Android as well as in Excel for the web.

The IMAGE function in Excel is designed to insert pictures into cells from a URL. The following file formats are supported: BMP, JPG/JPEG, GIF, TIFF, PNG, ICO, and WEBP.

The function takes a total of 5 arguments, of which only the first one is required.

IMAGE(source, [alt_text], [sizing], [height], [width])

Where

Source (required) - the URL path to the image file that uses the "https" protocol. Can be supplied in the form of a text string enclosed in double quotes or as a reference to the cell containing the URL.

Alt text (optional) - the alternative text describing the picture.

Sizing (optional) - defines the image dimensions. Can be one of these values:


0 (default) - fit the picture in the cell maintaining its aspect ratio.

- 1 fill the cell with the image ignoring its aspect ratio.
- 2 keep the original image size, even if it goes beyond the cell boundary.
- 3 set the image's height and width.

Height (optional) - the image height in pixels.

Width (optional) - the image width in pixels.

To make a basic IMAGE formula, we just need to give the first part, which is the web address (URL) of the picture. But remember, this address must start with HTTPS, not HTTP. Also, put this web address in double quotes like we do with normal text. It is also suggested that we write a description of the image as a second part to the formula



=IMAGE("https://cadcjain.in/wp-content/uploads/2023/11/ICAI-New-logo.jpeg")

Omitting or setting the 3rd argument to 0 forces the image to fit into the cell, maintaining the width to height ratio. The image will adjust automatically when the cell is resized.



If we decide to set the image's height and width (4th and 5th argument, respectively), make sure the cell is big enough to accommodate the original size picture. If not, only part of the image will be visible.

The Row height and column width will however have to be altered manually to get the image correctly visible in the cell.

Presently, the IMAGE function is under beta testing stage, so it's normal to encounter some problems.

We can only use images that are stored on external websites with "https" in their address. Images kept on OneDrive, SharePoint, or local networks won't work. Also, if we need to log in to access the website where the image is, the image won't show up. Moving from using a Windows to a Mac computer (or vice versa) might cause problems with how the image appears. Although GIFs are supported, they will only show as still images in a cell.

How a CA can become an Insurance Surveyor?

Many of the Chartered Accountants in Madurai may know that I am an Insurance Surveyor and I have been doing Insurance Surveys for the past 40 years. Though it is not very much attractive on the income side i.e the schedule of fees is not attractive, it is an interesting filed because doing survey itself will be like doing a work of detective and it gives us more opportunity to know about the claims assessment, procedure and settlement, which will be very useful while we do the audit of Insurance Companies. Long back it was very easy to get a license to act as a surveyor because the Controller of Insurance will grant license to a Chartered Accountant once an application is made with the required particulars and the fees. We, the Chartered Accountants, can conduct a survey for the claims made under Miscellaneous Policies (not for Motor and Fire) and LOP Policies. Bankers' Indemnity Insurance is one area where we can show our expertise. Other claims coming under Mis. Policies are Burglary and Fidelity Guarantee. After getting permission from our Institute, I have become a member of the Indian Institute of Insurance Surveyors and Loss Assessors; first an Associate Member and subsequently a Fellow Member. I am giving the procedure, which is very much available on the IRDA Site. As of now we have to pass an examination and serve as an apprentice under a Surveyor for 6 months to become an Insurance Surveyor.I am attaching the link of IRDA notification dated 24th November 2020 (Gazette Notification) and Guidelines for Practical Training for Surveyors and Loss Assessors dated 1st December 2020 issued by IRDA.
